At its sole discretion, Club management reserves the right to cancel any court availability as enumerated herein. To compensate for this cancellation, Club will provide, solely of its own choosing, either a refund for that period cancelled or additional court time.

Except as set forth above, Club has no obligation to refund or prorate any fees paid under this contract under any circumstances whatsoever. However, if Player(s) cannot use their court time, Club may provide a make-up for the date(s) missed but will have no obligation to do so.

Failure to provide all information, including signature(s), required under this contract and any applicable deposits will result in the contract not being honored, deposits being forfeited, and court(s) being made available for purchase by others.

At its sole discretion, Club management reserves the right to reject any contracts prior to their execution by the Club.

Should any governmental agency impose any tax applicable to the activities as described herein, Member(s) listed on this contract will be responsible for paying the same.

The club may at any time photograph and/or video record programs for future possible use in social and other media campaigns or advertising. Members(s) consent to their being captured, without compensation, for the aforementioned potential uses.
